



**Notification of the Office of the Prime Minister  
RE: Appointment of Operating Staff Officers  
Pursuant to the Alcohol Control Act, B.E. 2551 (A.D. 2008)**

By virtue of provisions of Section 4 of the Alcohol Control Act, B.E. 2551 (2008), the Prime Minister issues a notification as follows:

Clause 1. Civil servants of the Central Administration, Ministry of Public Health, holding office of the following positions, shall be appointed the competent officials under the Alcohol Control Act, B.E. 2551 (A.D. 2008):

(32) Public officials under the Alcoholic Beverages Control Commission, Department of Disease Control, of level 4 or above

(33) Public officials under the Bureau of Non-Communicable Disease, Department of Disease Control, of level 4 or above

(35) Public officials in the position of main management task support (legal officers), Department of Disease Control

Clause 2. Civil servants of the Ministry of Public Health, in the section of Provincial or Central Administration stationed in the provincial region and holding office of the following positions shall be appointed operating staff officers under the Alcohol Control Act, B.E. 2551 (A.D. 2008), only within the localities where they have authorization, duties and responsibilities to perform their tasks:

(1) Provincial Public Health Medical Doctor

(2) Preventive medicine and public health experts who are stationed at the Office of Provincial Public Health

(3) Director of the Bureau of Disease Prevention and Control No. 1-12, Department of Disease Control

- (14) Public health technical officers and community health care officers, under the Office of District Public Health and Health Station, of level 4 or above

Clause 3. Civil servants of the Ministry of Education who hold office the following positions shall be appointed operating staff officers under the Alcohol Control Act, B.E. 2551 (A.D. 2008) only within the localities where they have authorization, duties and responsibilities to perform their tasks:

- (1) Permanent Secretary of the Ministry of Education
- (2) Deputy Permanent Secretary of the Ministry of Education
- (3) Inspector-General of the Ministry of Education
- (4) Secretary-General of Higher Education Commission
- (5) Deputy Secretary-General of Higher Education Commission
- (6) Secretary-General of Basic Education Commission
- (7) Deputy Secretary-General of Basic Education Commission
- (8) Secretary-General of Vocational Education Commission
- (9) Deputy Secretary-General of Vocational Education Commission
- (10) Rector of every public and private higher education institute

Clause 4. Clause 5. Provincial Alcoholic Beverages Control Committee and Bangkok Alcoholic Beverages Control Committee shall be appointed the competent officials under the Alcohol Control Act, B.E. 2551 (A.D. 2008) only within the localities where they have authorization, duties and responsibilities to perform their tasks.

Clause 6. Civil servants of Bangkok Metropolitan Administration holding office of the following positions shall be appointed the competent officials under the Alcohol Control Act, B.E. 2551 (A.D. 2008) only within the localities where they have authorization, duties and responsibilities to perform their tasks:

Clause 8. Civil servants of the Excise Department, Ministry of Finance of the following positions shall be appointed the competent officials under the Alcohol Control Act, B.E. 2551 (A.D. 2008) only within the localities where they have authorization, duties and responsibilities to perform their tasks:

- (1) Director of the Bureau of Tax Administration 1
- (2) Director of the Licensing Division, Bureau of Tax Administration 1
- (3) Director of the Tax Analysis Division, Bureau of Tax Administration 1
- (4) Director of the Production and Distribution Control Division, Bureau of Tax Administration 1
- (5) Excise administrative officers under Bureau of Tax Administration 1
- (6) Excise officers and officials under Bureau of Tax Administration 1, of level 4 or above
- (7) Excise technical officers under Bureau of Tax Administration 1, of level 4 or above
- (8) Director of the Investigation, Prevention and Suppression Bureau
- (9) Excise administrative officers and excise inspectors under the Investigation, Prevention and Suppression Bureau, of level 4 or above

- (3) Director of Suvarnabhumi Airport Cargo Examination Customs Bureau

- (6) Director of Bangkok Port Customs Bureau
- (7) Director of Laem Chabang Port Customs Bureau

(13) Custom officers under the Investigation and Suppression Bureau, Suvarnabhumi Airport Passenger Control Customs Bureau, Suvarnabhumi Airport Cargo Examination Customs Bureau, Bangkok Customs Bureau, Bangkok International Airport Customs Bureau, Bangkok Port Customs Bureau, Laem Chabang Port Customs Bureau, and Regional Customs Bureau, of level 4 or above

Clause 10. Those Civil servants of the National Police Bureau being commissioned police officers with a rank of Police Sub-Lieutenant or in the position of Sub-Inspector or higher shall be appointed the competent officials under the Alcohol Control Act, B.E. 2551 (A.D. 2008) only within the localities where they have authorization, duties and responsibilities to perform their tasks.

Clause 11. This Notification shall come into force from the day following the date of its publication in the Government Gazette.
